ABSTRACT

Very few have been written about this journal that was been published from 1947 until 1967. It's title stands for "New Economy" and it was a tribune for economic thought in its time, hosting reports and articles of important Greek economists, journalists, sociologists, authors, even politicians, and translating some of the most important international intellectuals of its time. The subjects and the people writing in the journal belonged in the progressive political spectrum from centre-wing democrats to left-wing scholars. The journal was banned by the military jounta in 1967 and never got published again. Probably the banning act is the major reason that there are not a lot of issues surviving nowadays and even fewer in public libraries.

Our research took place in the library of the Greek parliament where the only in Greece known complete collection of the journal survives. As stated earlier, there is almost nothing written for this journal, so our paper is far from being a complete and thorough examination and is more of an attempt to enlighten the history of this quite unknown journal and boost researcher's interest to investigate in its contribution on the economic thought in Greece in the 20th century.
